I had a catch up meeting with the District Manager of the Nambour Hospital to discuss the progress of solving the parking woes at the hospital. It appears that some progress is being made, be it ever so slowly.

Back to Parsiament Tuesday July 31 was a fiery day in Parliament. I spoke on the Environmental Protection (Greentape Reduction) & Other Legislation Amendment Bill. One thing that we as a Parliament needs to do is cut red tape. During my speech I spoke on the plight of Bli Bli residents whose homes backed onto the Maroochy River. These people are dealing with three Government departments as well as our local Council, and they are being passed from pillar to post in their efforts to stop their homes from being washed into the river.

I spoke on the Motion for Queensland to support the proposed trial of the National Disability Insurance scheme. I have a great deal to do with a number of disability groups in our community and I believe there are times when instead of putting things in the too hard basket, we just need to find a way to make things happen. I suggested the money from the sale of land in the Mary Valley could be put toward this scheme.

I also spoke on the lack of time available for consultation in relation to the Penalties and Sentences and Other Legislation Amendment Bill. This Bill was introduced on July 11 and submissions in relation to the Bill closed July 17. Although I voted in favour of the Bill, I do not feel this was enough time for people to really consider the intent of the Bill and have a say.

It is once again an offence for Members of Parliament to lie to Parliament. This law should never have changed in the first place and we should expect that all Members of Parliament tell the truth. I hope that the intent of this amendment will also flow through to political candidates in elections. It just amazes me that sometimes we can be so righteous in the way we require everyone to perform in parliament, yet in the lead-up to an election campaign—the one we have just been involved in—some quite outrageous, appalling allegations and comments were made that clearly should not be allowed.

Tuesday August 14 I attended the Nambour Local Ambulance Committee AGM and after that I joined Members of the Palmwoods Woombye Lions Club for their changeover dinner.

I officially opened the Selangor Rehabilitation Unit on Thursday August 16. it is great to see this new service open in Nambour.

On Saturday August 18, I joined with the Sunshine Coast Vietnam Veterans for a commemorative service at the Cotton Tree Cenotaph.

Back to Parliament August 21, 22 and 23 In Parliament I spoke on the plight of the people in our Woombye Gardens Caravan Park and tabled letters from residents detailing their thoughts and fears. The government knows that once the caravan park is sold, there is no certainty that future rent will not increase, for people who want to remain on this site in Woombye,

I met with representatives of our Fire Service and Ambulance Service when they marched on Parliament. Many of our Fire officers and Ambos are worried about job security and reduced working conditions. I tabled one of their brochures in Parliament which calls upon the community to stand side by side with them, so that they can continue to provide 24/7 protection to the community. It is up to all of us to stand up for Ambulance Officers and Firefighters to ensure that Queenslanders get the Ambulance and Fire services they deserve.

During one of my speeches I took the opportunity to publicly thank some bighearted Sunshine Coast people, including Bill Hoffman, John Stokes and Ashley Robinson, who swam around Old Woman Island to raise thousands of dollars for our special school. I used this opportunity to again urge our Premier to reconsider his refusal to join the National Disability Insurance Scheme. I believe that as elected members of parliament we have a duty to care for those who for whatever reason cannot look after themselves. I believe it is disgraceful that the government is happy to pander to the big end of town but less than five months after the election it has stopped listening to many Queenslanders calling out for help.

I again raised the concerns of residents affected by the Northern Pipeline, in the hope that the Attorney General may be able to speed up the court process so that the problems can be resolved by the end of the year.

It was back to the office on August 24, with a Parliamentary Crime and Misconduct Teleconference to start the morning.

I opened a Diabetes Australia Expo at the Nambour Civic Centre on the Saturday ,which was followed by the Nambour Meals on Wheels AGM, where I was again elected to the position of Patron.

August 28, I attended the Nambour State High School Beacon Charter Signing. The Charter Signing is the main community activity of the Nambour State High Schools Beacon program. Students were invited to sign the pledge as evidence of their valued commitment - past present and future to their positive pathways.

That evening I was guest speaker at the Nambour Rotary meeting.

I finished the month of August with another busy day which started with the presentation of a community service certifi-
